# 2023-24 ISC ACTION PLAN

# I. ISC CHAIR and OFFICE of the CHAIR

- 1. Canvas members about the focus of a third peer review of the ISC function and process
- 2. Consult with Members about methods to formalize the ISC. The ISC Chair will email Heads of Delegations to request that members provide examples of appropriate agreements/letters, if available and permitted, that could be used to draft a "strawman" proposal for the ISC.
- 3. Climate change ISC Chair will contact other scientific organizations/RFMOs regarding their efforts to incorporate climate change considerations into management advice
- 4. Work with the Webmaster to compile a list of past officers of the ISC plenary and working groups for posting on the ISC website
- 5. ISC Vice-Chair to work with BILLWG chair to implement an external peer review of the 2023 MLS stock assessment following the newly adopted peer review process document (ISC/23/PLENARY/10).
- 6. Notify other organizations that they need to document requests to ISC separately in a letter to the ISC Chair

#### II. ISC MEMBERS

- 1. Members to develop presentations for ISC24 on climate change research and efforts to incorporate climate change in advice to managers. This information should be included in National Reports for ISC24 and will be presented separately from National Reports.
- 2. Provide summaries of all North Pacific Ocean HMS fisheries (annual catch by species and gear, number of vessels by gear and size category and average size of fish caught by species and fishery for entire NPO for at least ten years or since the start of the fishery) in National Reports; Freeze data as of the end of the last calendar year (e.g., Dec 2022 for the July 2023 ISC Plenary National Report) and to ISC database;
- 3. Submit ISC24 documents by dates set out below:
  - WG working papers are due to OOC and Webmaster immediately after completion of the WG workshop for posting on the ISC website;
  - April 30 Final Stock Assessment Reports due to OOC;
  - May 30 Final Stock Assessment Reports due to OOC for assessments completed in April
  - June 1 deadline for OOC to receive National Reports
  - June 10 distribution of all documents for Plenary meeting electronically.
  - June 1st Deadline for member countries to report Category I, II and III data to the ISC Final stock assessment reports.

4. Canada – prepare to host ISC24, June 19-24, 2024.

- 2. Archive 2023 NPALB stock assessment files with DA by November 1, 2023.

- 4. Work on updates to exceptional circumstances criteria, specifically incorporating HCR metrics.
- 5. Update abundance index for adult females.
- 6. Conduct workshop on research to improve the stock assessment.
