#### **2010-2011 ISC ACTION PLAN**

#### I. ISC CHAIRMAN

- 1. Contact other RFMOs to determine if interest in collaborating on a world blue marlin symposium in 2012 exists (6.3);
- 2. Organize and convene the first shark working group workshop (6.5);
- 3. Send letters of appreciation to 2010 Seminar presenters (6.6);
- 4. Continue seeking funding for proposed biological sampling program (9.0, 11.8);
- 5. Organize ISC Review Task Force for review of ISC function (11.2);
- 6. Send electronic version of the complete revised Operations Manual to ISC members after ISC10 (11.7);
- 7. Publish revised Operations Manual by the end of 2010 (11.7);
- 8. Make delegation reports available as soon as possible in advance of Plenary meetings (11.9).
