- 2. Work with China to encourage full participation in ISC activities (6.1)
- 3. Incorporate tables in Annex 11 into a revised ISC Operations Manual (6.5, 11.5)
- 4. Coordinate with WG Chairs to clarify the intent of proposed executive summaries for ISC stock assessment reports (6.5)
- 5. Consolidate WG data requests for appropriate RFMOs (9.1)
- 6. Amend the data reporting protocol to add discard data in Category I and II data provision, and if available, include the shark sex information in Category III data, if available (9.1).
